# Appraisal of Legal Opinion of Mr. T.J. Mahanta regarding guideship of Prof. J.K. Sarmah

As per Resolution No.8.2.1 of the 8<sup>th</sup> R.C. Meeting held on 22/06/2023, a legal opinion was sought from Mr. T.J. Mahanta (one of the members of empanelled advocates of KKHSOU) regarding continuation of the guideship of Prof. Jayanta Kumar Sarmah. Prof. Sarmah was allotted four Research Scholars by the University earlier. In this regard, Mr. T. J. Mahanta in his legal opinion has opined that the Research Council of the University may assign/allot any other regular Professor/full time teacher (as mentioned in Regulation 6 of the M.Phil./PhD Regulations, 2019) as the Research Supervisor for those Research Scholars who were earlier under Dr. Jayanta Kumar Sarmah, keeping in mind the greater interest of the Research Scholars. The report of the legal expert is attached as *Annexure IV*. The matter is placed for discussion and appropriate resolution. After thorough discussion about the various issues related with the matter, the meeting finally decided to defer the matter.

## Allotment of PhD Supervisor to Ms. Usha Das

Ms. Usha Das, a scholar in the Discipline of Assamese had applied for change of her PhD guide due to some personal ground for which as per Resolution No. 8.2.6. of the 8<sup>th</sup> R.C. Meeting held on 22/06/2023, an email was sent to Prof. Umesh Deka (Rtd.) on 26/07/2023 requesting him to place his opinion on the issue with no reply till date. At the same time, as per the Resolution No. 2.12 of the 37<sup>th</sup> Academic Council, a Committee was constituted to look into the matter and to submit a report on the same. The committee has submitted the report on the matter which is attached as *Annexure V*. The council has thoroughly discussed the matter and it is resolved that for the greater interest of the scholar, Dr. Sanjib Borah may be allowed to supervise the works of Ms. Usha Das so that she may complete her works without further delay.

RC. 9/2023/2/5	Regarding Exemption from PhD Course Work Classes
	A few PhD scholars of 2023 batch have applied for exemption from PhD Course Work classes as they have completed the same earlier (List is attached in Annexure VI). As per Clause No. 8.13 of the PhD Regulations, 2023 of KKHSOU, "If a scholar has already completed the course work with the required qualifying marks or grade as specified in these Regulations during his/her MPhil in KKHSOU or any other equivalent course work duly recognised/approved by the Research Council may be considered for granting exemption from undergoing PhD course work again. In such case (s) the Research Council shall have to take a specific decision with justification for allowing exemption to any scholar under this clause."  The matter was placed for discussion and appropriate resolution. After threadbare discussion about the coursework syllabus, credit points and other relevant issues of different Universities offering PhD Programme, it was concluded that only those scholars who had completed their M. Phil course works from KKHSOU within a term of five years be exempted from undergoing PhD course work again.
	Resolution No. RC/9/2.5/2023: Resolved that the scholars who had completed their M. Phil course works from KKHSOU within a period of five years be exempted from undergoing the PhD course work again.
RC. 9/2023/2/6	Approval of PhD Revised Course Work Syllabus
	As per Resolution No. 8.2.5 of the 8 <sup>th</sup> Research Council's Meeting, a committee was formed to revise the existing PhD Course Work Syllabus. The convenor of the committee, Prof. Joydeep Baruah had submitted the draft copy of the same which was attached as <i>Annexure VII</i> . It was placed before the council and after detail discussion, the council suggested that it should be implemented from the PhD course work classes of the current batch, i.e. 2023 batch.
