H N Sarma in respect of Shri Rajat Baran Mahanta, Registrar (under suspension) and comments/views received from Shri Rajat Baran Mahanta on the report of the Enquiry Officer.

It is for kind information of the Board of Management that in terms of the decisions of the 42<sup>nd</sup> Meeting of the Board of Management (emergent) held on 01.04.2018, the Enquiry Report submitted by Justice (Retd.) H N Sarma in respect of Shri Rajat Baran Mahanta, Registrar (under suspension) was forwarded to the Legal Adviser of the University with a request to suggest punitive measures to be taken on the basis of the findings of the Enquiry Report. The Legal Adviser has now submitted his opinion on the Report of the Enquiry Officer. A copy of the Report of the Enquiry Officer was sent to the Delinquent Officer, Shri Rajat Baran Mahanta. In the meantime the University has received the response/comments of Sri Rajat Baran Mahanta on the report of the Enquiry Officer.

The Board was requested to consider the legal opinion and the reply of Shri Rajat Barn Mahanta, Registrar (under suspension) and guide future course of action in this regard.

After detailed discussion, the Board of the Management decided as follows:

**Resolution No. BM/43/5(a)/2018:** Today's meeting has considered the representation submitted by Sri Rajat Baran Mahanta, Registrar (under suspension) against the Enquiry Report of Justice H N Sarma (Retd.) pertaining to the charges levelled against Sri Rajat Baran Mahanta. On perusal of the aforesaid

representation it has been resolved that the contentions raised therein are not acceptable.

Resolution No. BM/43/5(b)/2018: Today's meeting also discussed at threadbare about the gravity of the charges found to have been proved by the Enquiry Officer and therefore resolved that the penalty of Compulsory Retirement should be inflicted upon the erring official namely Sri Rajat Baran Mahanta with immediate effect and such an order of Compulsory Retirement may be issued by the University.

Today's meeting further resolved that the Resolution No. BM/43/5(c)/2018: above decisions on Sri Rajat Baran Mahanta be implemented without waiting for confirmation of the proceedings.

To consider and approve the MoU to be signed between the Item No: 6 Assam Agricultural University and the Krishna Kanta Handiqui State Open University on the construction of the City Campus of KKHSOU.

The Board is aware that in terms of the decision of the Meeting of the Board of Management an agreement on the construction of the City Campus of KKHSOU has been signed by the Assam Agricultural University and the Krishna Kanta Handiqui State Open University.
