The Hon'ble Vice Chancellor extended a warm welcome to all the members present. The Chairman called the 25th meeting of the Academic Council to order and requested Dean (Academic) to proceed with agenda items for consideration.

Item No.1: To consider confirmation of the minutes of the 24th meeting of the Academic Council, KKHSOU held on 28.08.2017.

Discussion: The members discussed the minutes of the 24th meeting of the Academic Council held on August 28th, 2017 as circulated by KKHSOU vide letter no KKHSOU/Academic Council/64/2010/27. The members pointed out certain corrections in the proceedings as follows -

- i. In the discussion section of item no.2, line no.4, may be drafted as "the Vice Chancellor selects the names two experts". In the same section point no.1, the line may be drafted as "the concerned guides be asked to suggest the names of nine experts". In the same point the word "then" in the last line be read as "than".
- ii. In the resolution of item no.3, the resolution may be drafted as "the Members resolved to note that the guidelines of UGC be followed while selecting scholars for the M.Phil/ PhD programme of the University".
- iii. In the discussion part of item no.4, the last line may be redrafted as "Minor modification as per UGC regulations in force from time to time".
- iv. In the item no.5, the heading may be drafted as "Reallocation of Guides".
- v. In the resolution of the same item no.5, it may be drafted as "Resolved that the list of the Reallocated Guides be approved along with the permission to further reallocate guides as per UGC guidelines".
- vi. In the resolution of item no.6, the resolution may be drafted as "Resolved that the requirements of ODL regulations of UGC, 2017 be fully complied with by the University".
- vii. In the discussion section of item no.7, the line may be drafted as "Director i/c CIQA placed before the Academic Council the matter regarding introduction of new programmes as follows."
 - Post Graduate Diploma in Energy Management
 - Diploma in Post-Harvest Management, Processing and Value Addition of Horticultural Crops.
 - Post Graduate Diploma in Environmental Studies
